INSTRUCTIONS

Renewals

- 1. Check the information shown, draw a line through any incorrect data and print the correction legibly.
- 2. Sign the application in the presence of an official when your photo is taken at one of the two locations provided above. **Mail-in photos will be returned and will delay the renewal process.**
- 3. Provide proof of citizenship such as birth certificate, voter's registration card or U.S. Passport.
- 4. Bring the renewal application and the \$35.00 fee. (Check or money order only, payable to DPS)
- 5. Legal Alien Residents need to provide Alien Registration numbers and 90-day proof of residency.
- 6. Naturalized citizens require proof of citizenship.
- 7. Security Officer's (Blue Cards/Class 1) and Bail Enforcement Agent (Gold Cards/Class 2) firearms permits will require an additional \$31.00 fee payable to DPS.

(REMINDER: There is a 90-day grace period after expiration.)

Out of State Applicants Only (Non-Residents)

(Renewals) Mail-ins are permitted from out-of-state-applicants with an attached color passport photograph (18% gray scale background – those not in compliance will be returned) with a notarized signature on the Form DPS-129-C mailed to Headquarters. Notary must sign at bottom of form, so as not to interfere with the signature or photograph of the applicant. (\$35.00 Check or money order only, payable to DPS) Legal Alien Residents need to provide Alien Registration numbers and 90-day proof of residency within their state and naturalized citizens require proof of citizenship.

Eligibility Certificates

- 1. Complete the enclosed application (DPS-799-C, DPS-164-C & DPS-129-C) and sign in the presence of an official when your photo is taken.
- 2. Submit a letter or certificate attesting that you have completed an approved course in the safety and use of pistols/revolvers. This must be signed by one of the following; an N.R.A. certified pistol instructor, a DEP certified instructor, or a state certified firearms instructor.
- 3. Submit a complete set of fingerprints with the application fee. (\$35.00 check or money order only, payable to DPS)
- 4. When applicable, criminal and/or mental health records must be submitted (C.G.S 29-36g).

NOTICE

Pursuant to Connecticut General Statutes, Sections 29-28, 29-32, 29-36f and 29-36f and Federal Public Law 104-208, s. 658: applications covered by these instructions will not be issued or be renewed, if:

You have a FELONY CONVICTION in any jurisdiction;

You have a MISDEMEANOR CONVICTION in Connecticut of one of the following crimes:

- 1. Illegal possession of controlled or hallucinogenic substances, as specified under C.G.S. 21a-279 (c)
- Criminally negligent homicide 53a-58
- 3. Assault in the third degree 53a-61
- 4. Assault of a victim 60 or older in the third degree 53a-61a
- 5. Threatening- 53a-62
- 6. Reckless endangerment in the first degree 53a-63
- 7. Unlawful restraint in the second degree 53a-96
- 8. Riot in the first degree 53a-175
- 9. Riot in the second degree 53a-176
- 10. Inciting to riot 53a-178
- 11. Stalking in the second degree 53a-181d

Or you were CONVICTED of a MISDEMEANOR CRIME of DOMESTIC VIOLENCE:

This means an offense that (1) is a misdemeanor under federal or state law; and (2) has, as an element, the use or attempted use of physical force, or the threatened use of a deadly weapon, committed by a current or former spouse, parent or guardian of the victim, or by a person with whom the victim shares a child in common, or by a person who is cohabiting with or who has cohabited with the victim or spouse, parent, or guardian, or by any person similarly situated to a spouse, parent or guardian of the victim.

You were discharged from custody within the preceding 20 years after having been found NOT GUILTY OF A CRIME BY REASON OF MENTAL DISEASE OR DEFECT 53a-13.

You were CONFINED TO A HOSPITAL for any psychiatric disability (17a-495) within the preceding 12 months by order of a judge of a probate court.

You are subject to a RESTRAINING ORDER or PROTECTIVE ORDER issued by a court in a case involving the use, attempted use or threatened use of physical force.

You are now subject to a Firearms Seizure Order issued pursuant to Public Act 99-212 Sec. 18, prohibiting possession of firearms.

You are an ILLEGAL ALIEN in the United States.

You are UNDER the AGE of 21 years.

You have renounced your United States citizenship.

You have been discharged from the Armed Forces under a dishonorable condition.

You are prohibited by Federal Law Section 922 (g) or (n) of Title 18 of the United States Code.

If you are in any of the above categories of persons, you should not file an application as it will be denied and your application fee may not be returned.

In order to effectuate Public Act 98-129, the Department of Public Safety herein notifies the applicant that the Department of Public Safety (DPS) will be notified by the Department of Mental Health and Addiction Services (DMHAS) if the applicant has been confined in a hospital for psychiatric disabilities within the preceding twelve (12) months by order of probate court.
